- 3 Encourage companies (related to technologies in livestock, food & agriculture) in India and in Bulgaria, to participate by way of taking stall space.


CII Agro Tech 2018 would thus provide a platform to strengthen our agri trade relations and drive new mutually advantageous agri deals of both nations.
